4. EXECUTIVE REPORTS

Se Chan (Andrew) Park:

I attended an OVPS meeting where we discussed supports for Iranian students, including referrals to registrars, and raised concerns around academic amnesty and tuition and OSAP changes; the university cited jurisdictional limitations and existing supports such as UTAPS. I also attended a consultation on body-worn cameras, with implementation planned for St. George first and UTM to follow. I met with a student regarding a public safety app for alcohol-serving venues and, after discussion with Shane (UTMSU General Manager), determined there is no current need at UTM given existing safety measures, while suggesting St. George may benefit. I also supported OSAP advocacy efforts, including hosting a town hall with MP Iqra Khaled, organizing a UTM rally and poster action, facilitating direct action training on de-escalation, and attending the Queen's Park rally. Additionally, I participated in a transferable skills workshop and completed an end-of-year interview with The Medium.

Rui (Owen) Zhang:

Since the last board meeting, I successfully organized the Lunar New Year Hot Pot Gala on February 13th in collaboration with the WeChat team. The event was supported by a Mississauga-based partner (Haidilao) who provided hot pot ingredients, and featured live performances, interactive games, and a raffle draw, with strong student engagement and positive feedback from attendees. I also completed hiring for the 2026 Spring Elections, appointing Dr. Susan Narain as Chief Returning Officer to ensure fairness and neutrality, alongside Deputy Returning Officers and poll clerks, with minor onboarding delays currently being addressed. Additionally, I oversaw HR processes, including posting the VP Campus Life and Orientation Coordinator roles, which have received two and three applications respectively to date.

Manaal Fatima:

Since the last board meeting, I attended a Clubs Committee meeting and continued tri-campus collaboration on the SAC initiative, including meetings with partner unions and preparation for an upcoming tri-campus registrar meeting where we will present our lobbying document. I participated in a Palestine Committee meeting and campaigns commission, where key legislation was discussed with external representatives. I have been developing an academic integrity package in collaboration with the Academic Integrity Unit and Downtown Legal Services, and am planning an upcoming initiative with them, alongside working on a citations and AI podcast with the library to be released in April. I also attended bursary committee meetings, a campus safety consultation on body-worn cameras, and supported OSAP advocacy efforts, including a town hall and direct action training. Additionally, I contributed to a scholarship review process, helping shortlist applicants, and participated in an end-of-year interview with The Medium.

Miatah McCallum:

February was particularly busy, beginning with the Blind Duck opening ceremony (~85 attendees) and events including a Success Panel with Black Future Lawyers, an Open Mic Night with the Black Literature and Arts Club, the African Students Association's Calabash Paint & Sit, the Somali Dabqaad Workshop with Studio X, and the Young, Gifted and Black campus closing gala, while the planned Black Professor and TA Night was postponed. I participated in key meetings and committees, including CRO and Deputy Returning Officer recruitment, the Elections and Referendum Committee, Bursary Committee, Sexual Violence Prevention Centre, Tri-Campus Council, Women's Coalition, and UTM Campus Affairs Committee, and advocated for a student regarding accessibility needs while connecting with the Ombuds Office and Office of Indigenous Initiatives. Black History Month programming was supported, and a \$5,000 sponsorship secured for Black alumni-related events, culminating in the upcoming Black Alumni Conference on April 11th. Equity and sustainability efforts advanced with a menstruation equity video series, pilot programs for heating pads and diva cups, equity handbook amendments, the equity audit, and Sustainability Week featuring 18 campus events. Financial literacy programming with BDO Financial Wellness was explored to educate students on responsible credit practices. Preliminary discussions with Black at UTM addressed cultural food pricing and other campus issues, with follow-up planned with senior administration in April.

Rajas Dhamija:

Since the last board meeting, I participated in multiple meetings and planned the Rangisari Pub Night with the Indian Student Association and UTM Bollywood. The Housing Committee was finalized, holding its first meeting on February 3rd to focus on research for the housing policy and upcoming Housing Advocacy Week. I attended the Council of Student Services meeting on February 10th and recorded a marketing video for the MiWay Route 48 in collaboration with the City of Mississauga's Instagram page, while also preparing transit maps for advocacy. After a brief absence for UTMSU elections, I resumed work on Housing Advocacy Week, with the main event, The Keys to Housing, scheduled for March 31st, featuring a workshop and expert panel on tenant rights and scam prevention. I held meetings with external partners, including House, RezRescue, and clubs, and attended the House General Member design consultation on March 23–24. The transit survey concluded in mid-March, providing data to support advocacy for improved frequency of routes 126 and Brampton 199 and exploring the possibility of a GO bus at UTM. Additionally, I met with UTM Administration to discuss these transit initiatives.

Lois Ogunnubi:

Over the past two months, we hosted several successful events, including the R&B Pub Night in collaboration with students, the Hair, Nails, and Black Culture event offering affordable self-care services, Free Dinner Fridays, a Montreal trip with strong logistics and ongoing hotel partnership, and the Black History Month Gala. I also attended the Black Caucus national conference, focusing on community and rest, and facilitated the International Women's Day dinner, which provided mentorship opportunities and meaningful engagement for students. Additional initiatives included the Spring Market for student and community businesses, a town hall to gather student input, and both on-campus and downtown UTM rallies, which saw increased student participation. I participated in multiple clubs committee meetings, addressed club complaints, and supported student engagement across campus initiatives. These activities collectively advanced cultural, social, and advocacy programming while providing students with leadership, networking, and learning opportunities.
